

## Viral Hepatitis Serology Testing Policy, Professional for Louisiana

### Application

**This reimbursement policy applies to UnitedHealthcare Community Plan Medicaid Product.**

This reimbursement policy applies to services reported using the 1500 Health Insurance Claim Form (a/k/a CMS-1500) or its electronic equivalent or its successor form. This policy applies to all products and all network and non-network physicians and other qualified health care professionals, including, but not limited to, non-network authorized and percent of charge contract physicians and other qualified health care professionals.

### Policy

#### Overview

This policy identifies circumstances in which UnitedHealthcare Community Plan will reimburse physicians or other health care professionals for viral hepatitis serology testing.

#### Reimbursement Guidelines

UnitedHealthcare Community Plan reimburses for viral hepatitis serology testing Current Procedural Terminology (CPT®) codes when one of the diagnosis codes listed on a claim indicates the presence of liver disease, liver abnormalities, or testing for these indications during pregnancy or infertility treatment. UnitedHealthcare Community Plan will not reimburse when the test is rendered without inclusion of one of the ICD-10-CM diagnostic codes being included on the claim accurately reflecting the member's condition.

The CPT codes and attached list of ICD-10 diagnosis codes were first derived by identifying areas of convergence across CMS Local Coverage Determinations (LCD).
