Application

This Medical Benefit Drug Policy only applies to the state of Ohio. Any requests for services that are stated as unproven or services for which there is a coverage or quantity limit will be evaluated for medical necessity using Ohio Administrative Code 5160-1-01.

Coverage Rationale

This policy refers to the following infliximab products:

- Avsola[®] (infliximab-axxq)
- Inflectra[®] (infliximab-dyyb)
- Remicade® (infliximab)
- Renflexis® (infliximab-abda)

Avsola, Inflectra, Remicade, and Renflexis are considered medically necessary in certain circumstances. For medical necessity clinical coverage criteria, refer to the Ohio Department of Medicaid Unified Preferred Drug List Criteria.
