Application

This Medical Benefit Drug Policy only applies to the state of Ohio. Any requests for services that are stated as unproven or services for which there is a coverage or quantity limit will be evaluated for medical necessity using Ohio Administrative Code 5160-1-01.

Coverage Rationale

This policy refers to Nplate (romiplostim) subcutaneous injection only for the treatment of chronic immune thrombocytopenic purpura (ITP) in patients who have had an insufficient response to corticosteroids, immunoglobulins, or splenectomy.

Nplate[®] (Romiplostim) is proven and medically necessary for the treatment of certain conditions outlined within the InterQual[®] criteria. For medical necessity clinical coverage criteria, refer to the current release of the InterQual[®] guideline for Nplate[®]: CP: Specialty Rx Non-Oncology, Romiplostim (Nplate[®]).
