1. Background:

Step therapy programs are utilized to encourage use of lower cost alternatives for certain therapeutic classes. This program requires a member to try one or more preferred topical products before providing coverage for Eucrisa (crisaborole).

Eucrisa (crisaborole) is indicated for topical treatment of mild to moderate atopic dermatitis in adult and pediatric patients 3 months of age and older.

The American Academy of Dermatology guidelines for the care and management of atopic dermatitis recommend topical corticosteroids, topical calcineurin inhibitors and topical phosphodiesterase-4 (PDE-4) inhibitors for the treatment of mild to moderate atopic dermatitis.

Patients currently on Eucrisa therapy as documented in claims history will be allowed to continue on their current therapy. For patients with claims history documenting prior use of either topical corticosteroids or topical calcineurin inhibitors, a prescription for Eucrisa will automatically process.

2. Coverage Criteria^a:

<p>A. All Diagnoses</p> <p>1. Eucrisa will be approved based on one of the following criteria:</p> <p style="margin-left: 40px;">a. History of failure, contraindication, or intolerance to one of the following topical therapies:</p> <p style="margin-left: 80px;">(a) One topical corticosteroid [e.g., mometasone furoate, fluocinonide acetonide (generic Synalar), fluocinonide]</p> <p style="margin-left: 80px;">(b) One topical calcineurin inhibitor [e.g., pimecrolimus (generic Elidel), tacrolimus (generic Protopic)]</p> <p style="text-align: center;">-OR-</p> <p style="margin-left: 40px;">b. Both of the following:</p> <p style="margin-left: 80px;">(a) Patient is currently on Eucrisa therapy</p> <p style="text-align: center;">-AND-</p>

(b) Patient has **not** received a manufacturer supplied sample at no cost in the prescriber's office, or any form of assistance from Pfizer sponsored programs (e.g., sample card which can be redeemed at a pharmacy for a free supply of medication) as a means to establish as a current user of Eucrisa*

* Patients requesting initial authorization who were established on therapy via the receipt of a manufacturer supplied sample at no cost in the prescriber's office or any form of assistance from the Pfizer sponsored programs **shall be required** to meet initial authorization criteria as if patient were new to therapy.

Authorization will be issued for 12 months

^a State mandates may apply. Any federal regulatory requirements and the member specific benefit plan coverage may also impact coverage criteria. Other policies and utilization management programs may apply.

3. Additional Clinical Rules:

- Notwithstanding Coverage Criteria, UnitedHealthcare may approve initial and re-authorization based solely on previous claim/medication history, diagnosis codes (ICD-10) and/or claim logic. Use of automated approval and re-approval processes varies by program and/or therapeutic class.
- Supply limits may be in place
